

## If you want FREE-DUMB then get an A-WARD

- Some of the most powerful adverts on TV were when the Road Accident Commission showed graphic video footage of the <u>events</u> leading up to an accident, the bloody aftermath after an accident, and then visiting the victims in their Hospital This impacted drivers to take care of and drive responsibly.
- Some of the most emotional and moving memories I have had in my 43 years as a travel agent is seeing diseases, famine, and war zones first-hand with emotional visits into Hospital <u>Cancer</u>
- I suggest that we give both <u>COVID</u>19 VAXXERS and also the minority ANTIVAXXERS the "FREE-DUMB" they want to make their own informed decisions based on their beliefs and convictions.

In the same way that a traveler can rely upon the internet to book travel, be scammed by whoever they want, not heed the advice of professional human travel agents, accepting the risks of possible misuse of their personal data and monies, we should also respect their wishes to make their own decisions and allow them to handle the consequences that they incur. Let us taxpayers offer –

- 1. <u>Free, taxpayer-funded visits</u> to Hospitals to see what the COVID19 virus delivers to humans, with free PPE equipment provided to enter waiting areas, wards and permissible IC units.
- 2. Free entry, accompanied by a Doctor, to have a short chat with victims of the COVID19 virus and their treating Doctor about their feelings and their progress.
- 3. <u>Free entry, after receiving permission by family</u>, to visit the morgue or cemetery of deceased victims of the COVID19 virus.
- 4. <u>Free, taxpayer-funded visit to Police HQ</u> to chat with Police officers and front-line Health Workers to chat about how they need to invest or divert their professional time and taxpayers' monies in controlling humans and demonstrators to follow their beliefs.
- 5. <u>Free, taxpayer-funded meetings</u>, with surviving and financially destroyed travel agents and other hospitality, travel, and tourism leaders who have been affected by the COVID19 virus, accompanied with free servings of Haigh's chocolates or Lavazza coffee or Earl Grey tea.
- 6. And finally, <u>a free taxpayer-funded meeting</u>, televised "live", with statistics extracted from the Government <u>Remuneration Tribunal</u> chaired by an experienced AFTA travel agent to investigate and compare what Politicians, Tourism Ministers, and some media-hungry Health Workers donated or had reduced from their salaries or how their staff or persons were sacked or suffered mental disorders from COVID19, against what Travel Agents, Travel industry suppliers and tourism and hospitality leaders have had to endure and suffer with their staff since March 2020. *This should be a very short and swift meeting*.
  - Our Government is meant to govern. Hence "GOVERN-MEANT"

The Commonwealth Government of <u>Australia</u> should pass SIX new bipartisan laws through Parliament to allow vaxxers and anti-vaxxers to follow their personal convictions. Of course in passing such Laws we must also respect that medically exempted anti-vaxxers should be given some relief and exemptions, but in the main, here is what I propose.

- New "GOVERN-MEANT" REGULATIONS
  - The Government should strip any taxpayer-funded Medicare payments or benefits that anti-vaxxers would normally get, to allow them to personally fund any medical expenses and not us-the taxpayer to respect the anti-vaxxer's convictions.

- The Government should reduce the current Federal Government taxpayer-subsidized monies given to Private Health companies if they pay any medical expense "gaps" incurred by an anti-vaxxer customer who stakes a claim via the COVID19 virus.
- The Government should respect the anti-vaxxer's beliefs, and allow admissions into taxpayer-funded Hospitals and Aged Care facilities in simple priority order, accepting the vaccinated humans first as a priority, then any anti-vaxxers, to comply with the anti-vaxxers mindset.
- The Government should introduce a new Federal Industrial Relations Law that overrides all Awards, Union demands, and rulings simply called *"THE BUSINESS PROTECTION UMBRELLA"*, that allows any business to apply at their discretion, this "umbrella" ruling which includes wearing of masks, social distancing, gaining entry only if fully vaccinated and using other Health protocols, that can deny dealing with or servicing any human to human contactable anti-vaxxer to protect against their business, their staff and their customers against any COVID19 related legal action. A simply signed disclaimer must be signed by all humans with each business voluntarily applying this new Law as needed, as some business interactions may pr may not involve human to human contact in providing that service or sale, so the application of such a new Law will satisfy the choice available to both vaxxers and antivaxxers. Under common law, a business is held responsible for staff and customers at all times, so they must provide protection as the legal costs and health issues that a Business may face would be totally devastating in costs and time.
- When travel truly opens up, the Government should mandate that a new "PANDEMIC DISCLAIMER" form be signed by all travelers via their Travel Agent, who have been and remain the most potent conduit between a traveler and a supplier. All travelers must read, agree to and sign off on this disclaimer to protect a Travel Agent and their suppliers, as Agents' work through the complex maze of State and International borders, dealing with everchanging Government Health department, Immigration and Supplier conditions and fees.
- Each State Government should work in harmony with anti-vaxxers and respect their personal health status and their wish to travel freely, as they wish. Each State <u>government</u> should work with AFTA and CATO and issue each anti-vaxxer with a special "EARLYBIRD HOLIDAY DEBIT VOUCHER worth \$2020" (year of COVID outbreak!) for each human they infect, of course, verified by the current Government COVID19 Tracing system, but with an additional and exclusive "BONUS TRAVEL OFFER "of a free PACKAGED PRISON HOLIDAY, valid for 12 months, bundled with a "FREE unapproved HVAC airconditioned LIMO prison-van transfer" from their home to a hand-selected Prison-cell, all generously pre-paid via monies extracted from taxpayer-funded Government Politicians salaries.
